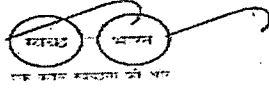

Sub:- Adjustment in Base Freight Rates -Classification of Commodities

Ref: - Railway Board's letter No. TCR/1078/2015/07 dated 16.03.2015 and dated
20.03.2015 (Rates Circular No. 8 of 2015 and Corrigendum thereto)

The contents of Railway Board's letter No. TCR/1078/2015/07 dt.30.09.2019
(Corrigendum No. 24 to Rates Circular No. 8 of 2015) is reproduced below for your
information and guidance.

- 1.1 In terms of Board's Corrigendum No.13 to Rates Circular No. 8 of 2015 dated 31.05.2016, it was decided to revise the classification of "Red Mud" appearing under the Main Commodity Head- Clay and Sand from Class -150 to Class - 120 up to 31.03.2017. These instructions were further extended in term of Corrigendum No. 22 to Rates Circular No. 8 of 2015 up to 31.03.2019.
- 1.2 In terms of Board's Corrigendum No. 23 to Rates Circular No. 8 of 2015 dated 26.03.2019, the classification of "Red Mud" was further revised to Class -130 for the period w.e.f. 01.04.2019 to 30.09.2019.
- 1.3 The matter has been reviewed and Competent Authority have now decided that Board's instructions dated 26.03.2019 shall be extended beyond 30.09.2019 for a further period of 6 months i.e. up to 31.03.2020.
- 1.4 All other details of the Rates Circulars under reference shall remain unchanged.
- 1.5 This issues with the concurrence of Finance Directorate of Ministry of Railways.
