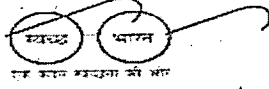

Sub:- Permissible Carrying Capacity of (PCC) of wagons.

Ref:- Railway Board's Rates Master Circular/PCC/2019/0 dated 16.05.2019 and Corrigendum thereto.

The contents of Railway Board's letter No. TCR/1394/2014/02 Pt. dt.11.10.2019 (Corrigendum No.12 to Rates Master Circular/PCC/2019/0) is reproduced below for your information and guidance.

1. In terms of Annexure-I to Board's Rates Master Circular/PCC/2019/0, Permissible Carrying capacity (PCC) and Loading Tolerance of various wagons have been notified.
- 1.1 The issue has been examined . It has been decided that for the purpose of charging of commodity "Pet Coke", Permissible Carrying Capacity (PCC) and Loading Tolerance, when loaded in "BOXN" and "BOXNHL" wagons on various routes shall be as under:

Type of Wagon	Excepted CC+6 Routes	Universalized CC+6 Routes	CC+8 Routes	Loading Tolerance
BOXN	63 T (for Pet Coke)	63 T (for Pet Coke)	63 T (for Pet Coke)	1 T
BOXNHL	66 T (for Pet Coke)	68 T (for Pet Coke)	68 T (for Pet Coke)	1 T

2. These instructions shall come into force with effect from 13.10.2019 and shall remain in operation for a period of six months, i.e. till 12.04.2020 on experimental basis.
