


1. विषय / Sub:- Rates of 'Haulage Charge per TEU' for movement of containers in privately owned wagons.

उपर्युक्त विषयक रेलवे बोर्ड के पत्र संख्या TC-I/2014/302/2 दिनांक 14/10/2019 (Addendum to Rates Circular No. 20 of 2018), आपके सूचनार्थ एवं आवश्यक कार्यवाही बाबत पूर्ण विवरण नीचे दिया जा रहा है।

A clarification has been sought regarding rates for charging of 22, 24 and 45 feet containers.

At present, the rates of Haulage Charge per TEU for movement of containers in privately owned wagons are stipulated vide Rates Circular No. 20 of 2018. As per the circular, rates for 40 feet containers will be levied 1.8 times the rates for a TEU.

The matter has been examined and it has been decided that in case of 22 feet and 24 feet container, Haulage Charge will be levied at par with 20 feet (TEU) container. In case of 45 feet container, Haulage Charge will be levied at par with 40 feet (FEU) container.

Accordingly, Rate Circular No. 20 of 2018 stands modified.


