TCR/1017/2017/01 दिनांक 23/10/2019 उपर्युक्त विषयक रेलवे बोर्ड के पत्र संख्या (Corrigendum No. 25 to Rats Master Circular dated 14.07.2016 on Block Rakes / Mini Rake/Two Point Combinations etc./2016/0), आपके सूचनार्थ एंव आवश्यक कार्यवाही बाबत् पूर्ण विवरण नीचे दिया जा रहा है।

In terms of Condition No.5 of Para 4.0 Mini Rake (Covered Wagon), issued vide Board's above referred Rates Master Circular, Mini Rake can be loaded only for distances up to 600 KM.

The matter has been reviewed and the Competent Authority have now decided that Mini Rake can be loaded for distances upto 1000KM subject to the condition that this relaxation is granted for only intra-zonal traffic and excludes Traditional Empty Flow Direction Traffic.

All other conditions prescribed in the Rates Master Circular under reference shall remain unchanged.

This shall come into force w.e.f. 24.10.2019 and shall remain in force till 31.03.2020.

This issues in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate of Ministry of Railways.
