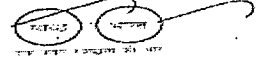

उपर्युक्त विषयक रेलवे बोर्ड के पत्र संख्या TCR/1015/2015/01 दिनांक 27/11/2019 (Rates Circular No. 24 of 2019), आपके सूचनार्थ एवं आवश्यक कार्यवाही बाबत पूर्ण विवरण नीचे दिया जा रहा है।

- 1.0 In terms of Rates Circular No. 11 of 2018 dated 31.05.2018, the freight rates for Automobile Traffic, when moved in NMG, BCCNR and BCACM wagons were revised and notified for the period from 01.06.2018 to 30.11.2018. Further in terms of Rates Circular No. 22 of 2018, the same were extended for the period from 01.12.2018 to 30.11.2019.
- 2.0 The matter has been reviewed by Board and sanction is accorded to extend the present rates for Automobile Traffic, when moved in NMG, BCCNR and BCACM wagons further for another one year i.e from 01.12.2019 to 30.11.2020.
- 3.0 All other terms and conditions mentioned in above referred Rates Circular No. 11 of 2018 dated 31.05.2018 shall remain the same.
- 4.0 This issues in consultation with Freight Marketing Directorate and with the concurrence of Finance Directorate of Ministry of Railways.
