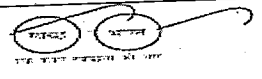

विषय / Sub:- Revision of Standard Rake Size of wagon type BAFRDR.

संदर्भ / Ref:- Railway Board's Rates Master Circular/2016 dated 14.07.2016 on Block Rake/Mini Rake/ Two Point Combination etc. and corrigendum thereto.

उपर्युक्त विषयक रेलवे बोर्ड के पत्र संख्या TCR/1017/2019/01 दिनांक 17/12/2019 (Corrigendum No. 28 to Rates Master Circular/2016 dated 14.07.2016 on Block Rake/Mini Rake/Two Point Combination etc.), आपके सूचनार्थ एवं आवश्यक कार्यवाही बाबत पूर्ण विवरण नीचे दिया जा रहा है।

- 1.0 In terms of Corrigendum no.27 to above referred Rates Master Circular, Minimum number of wagons to be loaded for trainload benefit for BAFRDR wagon type were notified.
- 2.0 Matter has been reviewed and in supersession to the above the Competent Authority has decided to revise details of rake size of BAFRDR wagon type as under:

Type of Wagon	Standard Rake Size	Minimum number of wagon required to be loaded for availing trainload benefit
BAFRDR	51 including (EAB) End Articulated Bogie	31 including (EAB) End Articulated Bogie i.e. thirty (30) BAFRDR+one (1) EAB.

- 3.0 All other details of the Rates Master Circular & Corrigenda thereto under reference shall continue to apply unchanged.
- 4.0 These instructions shall come into effect from 19.12.2019 and shall remain valid till 21.09.2020.
- 5.0 This issues with the concurrence of Finance Directorate of Ministry of Railways.
