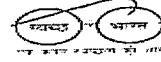

उपर्युक्त विषयक रेलवे बोर्ड के पत्र संख्या TC-I/2019/201/2 दिनांक 19/12/2019 (Corrigendum No.8 to Rates Master Circular/Demurrage-Wharfage-Waiver/2016/0), आपके सूचनार्थ एवं आवश्यक कार्यवाही बाबत पूर्ण विवरण नीचे दिया जा रहा है।

Please refer to Para 6.3 of Chapter -I of Rates Master Circular under reference regarding rate of Stabling Charge.

The matter has been examined and it has been decided to revise the rate of Stabling Charge by modifying the Para 6.3 of Rates Master Circular under reference, as under:

Existing Para:

"6.3: Rates of Stabling Charge will be Rs.500/- per wagon per day or part of a day, from the time of arrival to the time of removal".

Modified Para:

" 6.3: The rate of Stabling Charge in case of privately owned wagons (except wagons owned by container operators) will be Rs.525/- per wagon per day or part of a day, from the time of arrival to the time of removal. In case of wagons owned by container operators, the rate of Stabling Charge will be Rs.525/- per wagon per day or part of a day".

These instructions will come into force w.e.f 01.01.2020 and will remain valid up to 31.03.2021.

This issues in consultation with Traffic Transportation Dte. and with the concurrence of Finance Dte. of Ministry of Railways.
