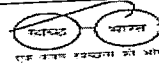

- 1.0 In terms of Board's letter referred at (i) above, West Central Railway have forwarded proposal with due approval of the General Manager to include Ramganj Mandi (RMA) – Jhalawar City (JLWC) (SL) BG section of Kota Division of West Central Railway in the CC+8 routes.
