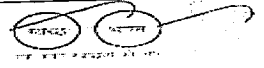

Please refer to Board's letter No. TC-I/2014/302/02 dt. 12.12.2018 regarding discount on the extant Haulage rate per TEU for movement of empty containers and empty flat wagons. These guidelines are valid upto 31.12.2019.

The matter has been reviewed and it has been decided to extend the currency of above mentioned guidelines beyond 31.12.2019 for a further period of three months i.e. up to 31.03.2020.
