1. The above merit list is purely provisional is liable to be altered/modified/interpolation of names and even cancelled based on the facts brought to the notice of the administration at any stage. No calculation/conversion of mark into percentage has been done by the system or by manual. Administration has the right to modify, cancel or add any name(s) due to typographical error.

2. Objections (if any) on the above merit list may be submitted from 10.01.2020 to 17.01.2020.

3. The date/venue of document verification:- from 27.01.2020 to 31.01.2020 at Sr.DPO Office, DRM Complex, SEC Railway, Raipur at 10:00 Hrs.

4. The final merit/select list will be published after verification of original certificates and subject to found correct in all respect.

5. If it is noticed by the Railway Administration that an applicant has furnished wrong information/fake certificate, the Railway Administration reserves the right to discharge the candidates/selected candidates at any stage without notice after his selection to undergo training.

6. Candidates are advised to get the various documents in the support of their qualification, communities, disability issued by the competent authority in the prescribed format only as indicated in the above notification. Mere enlisted in above provisional list confers no right for further consideration for engagement if the candidature and relaxation claimed could not be established as desired.

7. The candidates will have to produce hard copy of their online application at the time of document verification and same will be retained in the office.
8. The candidates should bring all the educational certificates, latest community certificate and at least three passport size photo graphs for the document verification.
9. Candidates should also bring a copy of one set of all certificates (self-attested) and the same will be retained by the office.
10. The candidates availing the benefits of reservation of ex-serviceman must produce the discharge certificate from the force during document verification.
11. PWD availing the benefits of reservation of disability must produce the disability certificates issued by the competent authority at the time of document verification.
- 12. The candidates are advised to bring medical certificate at the time of document verification. The medical certificate should be signed by Government authorised doctor (Gaz.), not below the rank of Asst. Surgeon of central/State Hospital. In Medical Certificate is clearly indicated by the Doctor that you are medically fit for apprenticeship training in the relevant trade. (Profarma enclosed)**
13. Change of date, time venue of document verification will not be permitted under any circumstances.
14. No daily allowances /conveyance allowance or travelling allowance will be paid to the candidates called for document verification.
15. Candidates are hereby advised not to fall prey to any unscrupulous elements promising to give engagement as Act Apprentice in Railway. The engagement is purely based on the merit only the genuine candidates found suitable in all respect will be considered.
16. Request for change of information once filled during online application will not be considered during document verification. Hence, candidates should ensure correctness of information in their respective hard copy of online application in reference to the certificate before coming for document verification.
17. Standby candidates are the wait-listed candidates. They will only be considered for empanelment for apprenticeship when there will be shortfall in main list.
- 18. The List of candidates provided by the Ministry of Skill Development and Entrepreneurship does not indicate the category of Ex-serviceman and EWS, therefore no separate merit list of candidates belonging to Ex-serviceman and EWS category is being notified for the present separately. Candidates belonging EWS and Ex-serviceman category who have registered in the Ministry of Skill Development and Entrepreneurship Portal within the date of notification, can claim reservation/relaxation by submitting relevant certificate on 27.01.2020 to 31.01.2020 along with all their correspondence related papers and certificates.**
