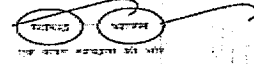

Sub : Permissible Carrying Capacity (PCC) of Wagons – Steel Pipes.

Ref : Railway Board's Rates Master Circular/PCC/2019/0 dated 16.05.2019 and Corrigenda thereto.

1. In terms of Annexure-I to Board's Rates Master Circular/PCC/2019/0, Permissible Carrying Capacity (PCC) and Loading Tolerance of various wagons have been notified. An issue of loading of steel pipes has been raised by Zonal Railways.
2. This issue has been examined, It has been decided by the Competent Authority that for the purpose of charging of commodity "Steel Pipes" (of different diameters), when loaded in "BOST" wagons, Permissible Carrying Capacity (PCC) and Loading Tolerance, on various routes shall be as under :

3. It must be ensured by the Goods Clerk that the customer has declared on forwarding note the diameter of the steel pipes that shall be loaded on to the wagons. The declaration on the forwarding note must mention either, (a) that the steel pipes are of diameter ≤16 inches or, (b) that the steel pipes are of diameter >16 inches. In case it is found en-route or at destination that the diameter of the loaded steel pipes are at a variance with the declaration on the forwarding note, the party shall be liable to pay the difference in freight and penalty as per the extant rules. In any case of mis-declaration, the extant rules of penalty as laid down vide Rates Instructions No. 95 of 2006 shall apply.

Corrigendum No. 19 to RATES CIRCULAR/PCC/2019/0

4. In case a wagon is loaded with mixed diameter pipes of ≤ 16 inches and > 16 inches, then PCC at 63 tonnes shall be applicable.
5. The Zonal Railway must put in place a suitable monitoring and preventive mechanism to ensure proper implementation of these instructions.
6. These instructions shall come into force w.e.f. 20.02.2020 and shall remain in operation till 31.03.2021 on experimental basis.
7. This issues in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate of Ministry of Railways.
