कार्यवाही बाबत पूर्ण विवरण नीचे दिया जा रहा है।

1. Please refer to Corrigendum No.8 to Rates Master Circular/FIS/2015/0 vide which
Private Freight Terminals were included in the Permitted Terminals for Incentive
Scheme for Freight Forwarders. It was further extended vide Corrigendum No.9 to
Rates Master Circular/FIS/2015/0 up to 31.03.2020.
 2. The matter has been reviewed, and the Competent Authority, has decided to
extend the validity of the inclusion of Private Freight Terminals (PFTs) for
Incentive Scheme for Freight Forwarders beyond 31.03.2020, for a further period of
one year i.e. upto 31.03.2021.
 3. All other terms and conditions mentioned in Rates Master/FIS/2015/0 shall
remain unchanged.
 4. Periodic review may be undertaken and feedback be apprised to Board's office for
further evaluation of the scheme.
 5. This issues in consultation with Traffic Transportation Directorate and with the
concurrence of Finance Directorate of Ministry of Railways.
