

सूचनार्थ एवं आवश्यक कार्यवाही बाबत पूर्ण विवरण नीचे दिया जा रहा है।

1. Please refer to S.No. 3 of Table in Para 2 of Rates Master Circular/Dynamic Pricing Policy/2015/0 dated 20.07.2015 notifying Congestion Charge for all traffic booked to Bangladesh and Pakistan @ 25% & @ 20% respectively throughout the year applicable on Base Freight Rates as mentioned in the Goods Tariff..
2. The matter has been reviewed and the Competent Authority have now decided that the above Congestion Charge shall also be applicable on haulage charges, notified by Board from time to time, of all Container traffic booked to Bangladesh and Pakistan.
3. These instructions shall come into force with effect from 14.03.2020 and shall remain valid till further advice.
4. This issues in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate of Ministry of Railways.
