


(Corrigendum No.25 to Rates Circular No.8 of 2015)

The contents of Railway Board's letter No. TCR/1078/2015/07 dated: 21.04.2020 (Corrigendum No.25 to Rates Circular No.8 of 2015) is reproduced below for your information and guidance.

1. In terms of Board's Corrigendum No. 13 to Rates Circular No.8 of 2015 dated 31.05.2016, it was decided to revise the classification of "Red Mud" appearing under the Main Commodity Head- Clay and Sand from Class-150 to Class - 120 up to 31.03.2017. These instructions were further extended up to 31.03.2019.
2. Subsequently, the classification of "Red Mud" was further revised to Class-130 for the period w.e.f. 01.04.2019 to 30.09.2019 and the same was further extended up to 31.03.2020 and 30.04.2020.
3. The matter has since been reviewed. After careful consideration Competent Authority have now decided to revise the classification of "Red Mud" at **Class-120 beyond 30.04.2020 for a period up to 31.03.2021.**
4. All other details of the Rates Circulars under reference shall remain unchanged.
5. This issues in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate of Ministry of Railways.
