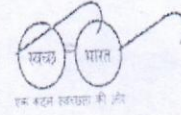

Please refer to this office Rates Circular No.163(G)/2012 dated 20.12.2012, wherein Goods Shed siding at Saragbundia (SRBA) station was temporarily closed from 21/12/2012 to 31/03/2013 due to conversion of Goods Shed siding into common loop.

With the approval of competent authority i.e. (PCOM & PCCM), now this Goods shed siding is re-opened subject to observation of all necessary formalities for facilities and compliance of extant rules.
