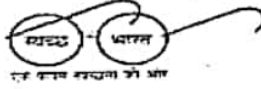


Sub: Haulage Charge for movement of Toluene in containers

Ref: Rates Master Circular/CRT-CCR-Hub&Spoke/2015/0 and its corrigenda/addenda

Please refer to Corrigendum No.29 to Rates Master Circular/CRT-CCR-Hub&Spoke/2015/0 vide which 'Toluene' has been excluded from the list of notified commodities. These guidelines are valid upto 26.07.2020.

The matter has been reviewed and Competent Authority has now decided to extend the validity of the above-mentioned guidelines beyond 26.07.2020 till further advice. Accordingly, 'Toluene' will continue to be charged at Haulage Charge per TEU basis, instead of Container Class Rate(CCR), beyond 26.07.2020.

This issues in consultation with Traffic Transportation Dte and with the concurrence of Finance Dte. of Ministry of Railways.






