Sub: Grant of Co-user permission to use the Private Railway siding of M/s Jindal Steel & Power Ltd, /KDTR (JSLK).

With the approval of competent authority i.e. PCOM & PCCM, co-user permission is granted to **M/s Nalwa Steel & Power Ltd.** to use the Private siding of **Jindal Steel & Power Ltd./KDTR (JSLK)** served by KDTR station for inward traffic of **Coal and Iron Ore.** The above permission will be valid **from 17.07.2020 to 15.07.2021.**

The following terms and conditions to be followed:-


1. The first priority will be given to the traffic of JSLK for placement of empties and withdrawal of rakes.
2. Siding owner will be responsible for clearance of all tollage liability (such as freight, demurrage and other charges) which will be accrued due to use of siding by co-user will be paid by siding owner.

3. There should be no inconvenience to the work of siding owner during the use of siding.
4. The Railway reserves the rights itself to withdraw the permission at any time without serving any prior notice or assigning any reason.
5. The grant of this co-user permission will be without prejudice to the fulfillment of all terms and conditions of the siding.
6. The siding will remain open for 24.00 hrs. working.
7. In case of failure for making the payment of any dues, the facility will be withdrawn immediately.
8. In case of exigencies if any, the siding has to be vacated immediately.
