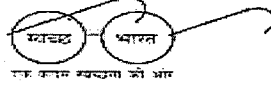

Sub **Discount on Haulage Charge for movement of loaded containers**  
Ref Rates Circular No.20 of 2018 and its corrigenda

Please refer to Rates Circular No.20 of 2018 and its corrigenda regarding Haulage Charge per TEU for movement of containers in privately owned wagons.

The matter has been examined and the competent authority has decided to permit a discount of 5% on Haulage Charge per TEU rates for movement of loaded containers from 01.08.2020 to 30.04.2021. Post which, normal guidelines will be applicable.
