**Sub: Notification for charging of freight on through distance basis at Private siding of M/s Mahavir Coal Washeries Private Limited served by Janjgir Naila station of Bilaspur Division on S.E.C.Railway.**

Reference is invited to this office Rates Circular No. 48(G)/2020 dated:31.03.2020, wherein private siding of **M/s Mahavir Coal Washeries Private Limited (PMCJ) served by Janjgir Naila station** was notified temporarily for a period of 06 (six ) months on shunting charge basis for inward and outward traffic of Coal.

Now, the siding has been electrified and is qualifying for **through distance charging on regular basis**. The freight will be charged up to dead end by reckoning the distance from **Janjgir Naila (NIA) + 3.555 Kms.**

All terms and conditions notified earlier will remains unchanged. Necessary RBS database may be updated accordingly.
