Sub: **Guidelines for installation of weighbridge by private party on railway land**
Ref: Rates Master Circular Provision of Weighbridge/2019/0

Please refer to "Para 4.2 By private siding owner on railway land" and "Para 4.3 By private party on railway owned goods sheds" of Rates Master Circular/Provision of Weighbridge/2019/0.

As per sub-para 4.2.2 (also quoted in Para 4.3), GM may grant permission for installation of weighbridge on railway land by private party

The matter has been reviewed and it has been decided to delegate the power of General Manager to Divisional Railway Manager for permitting installation of weighbridge by private siding owner on railway land and also by private party on railway owned goods shed.

Existing and revised Para 4.2.2 and Para 4.3 of Rates Master Circular/Provision of weighbridge/2019/0 are given below-

EXISTING PARA

"4.2.2 In case it becomes unavoidably essential to install the weighbridge of private siding either wholly or partially on railway land, on account of operational and technical constraints, permission may be granted by the **General Manager of Zonal Railways**; the location of such EIMWBs would be decided by the COM in consultation with CCM, PCE and CME."

"4.3 By private party on Railway owned goods sheds

General Manager of Zonal Railways may permit the installation of electronic in-motion weighbridge by private party at Railway owned goods sheds as per the terms and conditions laid down vide Paras 4.2.2 to 4.2.5 mentioned above."

REVISED PARA

"4.2.2 In case it becomes unavoidably essential to install the weighbridge of private siding either wholly or partially on railway land, on account of operational and technical constraints, permission may be granted by the **Divisional Railway Manager**; the location of such EIMWBs would be decided by the Sr. DOM in consultation with Sr. DCM, Sr. DEN and Sr. DME."

Private party at Railway owned goods sheds

Divisional Railway Manager may permit the installation of electronic in-motion weighbridge by private party at Railway owned goods sheds as per the terms and conditions laid down vide Paras 4.2.2 to 4.2.5 mentioned above."

All other extant instructions will continue to apply unchanged.

This issues in consultation with T. T., L&A and Mechanical directorates and with the concurrence of Finance directorate of Ministry of Railways.
