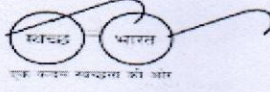


hereby accorded to include above referred routes of Northern Railway in the list of already identified CC+8 routes.
