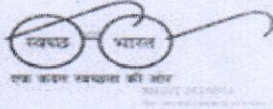

1.0 By utilizing the powers delegated by Board's in terms of letter referred at (i) above, South Western Railway has forwarded proposal with due approval of General Manager to include following route in the list of already identified CC+8 routes:

S.No.	Railways	Routes
1.	South Western Railway	Vijayapura (BJP)-Hotgi (HG)

2.0 Please refer to Annexure III to Rates Master Circular under reference at (ii) above, wherein list of CC+8 routes is prescribed. Now, sanction of the Competent Authority is hereby accorded to include the above referred route of South Western Railway in the list of already identified CC+8 routes.

The Section Bagalkot- Hotgi is already mentioned in Annexure-II of Rates Master Circular under reference at (ii) above, as Excepted CC+6 routes. The same shall be

treated as deleted.

3.0 All other details of the Rates Master Circular & Corrigenda thereto under reference shall continue to apply unchanged.

4.0 These instruction shall come into effect from 25.09.2020 and shall remain valid till further advice.

5.0 The Rates Master Circular under reference accordingly be modified.

6.0 The issues in the consultation with Traffic Transportation and with the concurrence of Finance Directorate of Ministry of Railways.
