Reference is invited to this office Rates Circular No.54(G)/2020 dated: 28.04.2020, wherein, approval of Railway Board regarding extension of validity of New Pahara private siding of DFCCIL served by Pahara station (**Alpha Code-PNPP** and **Numerical Code-13209176**) was notified for six months (w.e.f. 01.05.2020 to 31.10..2020) for movement of rakes of BRNA wagons fitted with special fixture for 260 meter long rails by M/s Jindal Steel and Power Ltd. under the SFTO scheme.

Now, Dy. DFM/Railway Board vide their letter under reference No.1 have communicated that the validity of New Pahara private siding of Dedicated Freight Corridor Corporation of India Ltd. (DFCCIL) served by Pahara station has been extended for receiving the RMC cargo for further period of one year from 01.11.2020 to 31.10.2021.
