

In case of underutilized Group-III CRTs, advance stacking permission for more than above-mentioned five days period may be permitted by PCCM in consultation with PCOM. The Ground Usage Charge for such underutilized Group-III CRT will be decided by PCCM and PCOM in consultation with PFA.

This modification in extant guidelines of Para 3.4.3 shall be valid for an initial period of one year.

This issues in consultation with Traffic Transportation Dte. and with the concurrence of Finance Dte. of Ministry of Railways.




