The Contents of Railway Board's letter No.TCR/1394/2020/4-Part(2)/3335729 Dated 25.11.2020. Corrigendum No.12 to Rates Master Circular/PCC/CC+8 etc/2020/0. is reproduced below for your information and guidance.

1.0 In terms of reference at (i) & (ii) above, Board's approval was communicated for Restarting of 25 Tonne axle load operation with such rolling stock as are fit/certified for 25 Tonne axle load on the following notified routes:
