With the approval of competent authority, co-user permission is hereby accorded to **M/s CONTAINER CORPORATION OF INDIA LTD. (Customer Code-CONR)** to use the private siding of **M/s UltraTech Cement Ltd./HN (Alpha Code: MGCH)** for a period of **06 (Six) Months** only for loading of **Cement and Clinker** in containers on following terms & conditions:-

1. A close watch on Rail co-efficient to be kept as per policy guidelines issued by Rly. Board vide Letter no.2009/TT-III/73/9 dated 10.12.2010, 12.08.2014 & 07.06.2019.
2. The traffic belonging to siding owner only can be handled i.e. no 3rd party Cargo will be handled.
3. The first priority will be given to the traffic of M/s UTCL for placement of empties and withdrawal of rakes.
4. The siding owner will be responsible for clearance of all tollage liability (such as freight, demurrage, siding charges and other charges) which will be accrued due to use of the said siding.
5. There should be no inconvenience to the work of siding owner during the use of siding.
6. The Railway reserves the rights itself to withdraw the permission at any time without serving any prior notice or assigning any reason.
7. The grant of this user permission will be without prejudice to the fulfillment of all terms and conditions of the siding.
