
Reference above, the matter has been relooked into and the Competent Authority have decided to clarify the levy of supplementary charges as under:

1. Please refer to Para 2.0(b) of above referred Board's Circular notifying supplementary charge on movement of Mini Rake as per Para 4.0 of Board's Rates Master Circular on Block Rakes/Mini Rake/ Two Point Combination etc.2020. For better appreciation, illustration for charging is appended below:

Distance for Mini Rake in KM	Rate of supplementary charge	Charging of commodity will be at
0 to 500	Nil	Trainload class rate
Beyond 500 up to 1000	5%	Trainload class rate for total distance + supplementary charge @5% on difference of base freight of respective distance and base freight of 500 km
Beyond 1000 up to 2000	7.5%	Trainload class rate for total distance + supplementary charge @5% on difference of base freight of 500km and base freight of 1000 km + supplementary charge @7.5% on difference of base freight of respective distance and base freight of 1000 km
Beyond 2000	10%	Trainload class rate for total distance + supplementary charge @5% on difference of base freight of 1000 km and base freight of 500 km + supplementary charge @7.5% on difference of base freight of 2000 km and base freight of 1000 km + supplementary charge @10% on difference of base freight of respective and base freight of 2000 km.
