Reference is invited to this office Rates Circular No.06 (G)/2016 dated:08.01.2016, wherein Garha Goods Shed (Alpha Code-"GGGS", Numerical Code- "14223548") was notified to handle the following commodities:-

Inward:- All traffic including Coal and Crane consignment except POL.

Outward:- All traffic including Crane consignment except Coal & POL.

Now, with the approval of competent authority (i.e. PCOM & PCCM), Garha Goods Shed is de-notified for all inward traffic for a period of 03 (Three) months from 11.01.2021 to 10.04.2021.
