In terms of Annexure -II of Rates Master Circular on Block Rakes/Mini Rake/Two Point Combination etc./ 2020 and corrigenda thereto, a list of Two Point Combination for other than covered stock (for steel traffic only) has been notified. The matter has been reviewed and the Competent Authority have decided to add in Annexure- II, the following combinations:
