1. By utilizing the powers delegated by Board in terms of letter referred at (i) above, Western Railway has forwarded proposal with due approval of the General Manager to include following routes in the list of already identified CC+8 routes:

2. Please refer to Annexure III to Rates Master Circular under reference at (ii) above, wherein list of CC+8 routes is prescribed. Now, Sanction of the Competent Authority is hereby accorded to include above referred routes of Western Railway in the list of already identified CC+8 routes.
3. All other details of the Rates Master Circular & Corrigenda thereto under reference shall continue to apply unchanged.
4. These instructions shall come into effect from 22.01.2021 and shall remain valid till further advice.
