1.0 By utilizing the power delegated by Board's in terms of letter referred at (i) above, Eastern Railway has forwarded proposal with due approval of General Manager to include following route in the list of already identified CC+8 routes:

2.0 Please refer to Annexure III to Rates Master Circular under reference at (ii) above, wherein list of CC+8 routes is prescribed .Now, Sanction of the Competent Authority is hereby accorded to include above referred route of Eastern Railway in the list of already identified CC+8 routes.

3.0 Accordingly Annexure-III of Rates Master Circular under reference (ii) above shall be modified.

4.0 All other details of the Rates Master Circular & Corrigenda thereto under reference shall continue to apply unchanged.

5.0 These instructions shall come into effect from 04.02.2021 and shall remain valid till further advice.
