उपर्युक्त विषयक रेलवे बोर्ड के पत्र संख्या. TCR/1015/Automobile/2020/02/3325247 dated.01.04.2021 (Corrigendum No. 05 to Rates Circular No.24 of 2019) आपके सूचनार्थ एवं आवश्यक कार्यवाही बाबत पूर्ण विवरण नीचे दिया जा रहा है

1. In terms of Rates Circular No. 11 of 2018 dated 31.05. 201, the Rate Table notifying the basic freight per wagon for NMG, BCCNR and BCACM Wagons for transportation of Automobile Traffic was notified w.e.f.01.06.2018. Validity of this rate table is up to 30.11.2021 in terms of Corrigendum No.1 to Rates Circular No.24 of 2019.

2. Matter has been reviewed and the Competent Authority has decided to notify wagonload rates for automobile traffic when moved in NMG, BCCNR and BCACM Wagons.

3. Para 2 of Rates Circular No.19 of 2016, accordingly modified by inserting a footnote "The wagon load rates shall apply if the wagons loaded by the customer are less than minimum composition subject to loading of minimum 10(ten) number of wagons"

4. Rates Table indicating the basic freight for Trainload as well as wagonload per wagon for automobile traffic when moved in NMG, BCCNR and BCACM Wagons is attached as Annexure.

5. The revised wagon load rate table shall come into force w.e.f 15.04.2021 and shall remain valid till 30.11.2021.

6. This issues in consultation with Traffic Transportation, Freight Marketing Directorates and with the concurrence of Finance Directorate of Ministry of Railways.
