Reference is invited to this office Rates Circular under reference, wherein Sukli Station (Line No.1) (Alpha Code-SKLI, Numerical Code-14223510) under Nagpur Division on SECR was opened for outward loading of Sand traffic on temporary basis for a period of 04 months i.e. from 12.01.2021 to 11.05.2021.

Now, with the approval of competent authority i.e. (PCOM & PCCM), the validity period of the above Railway Goods Shed (SKLI) is extended for 01 (one) month only i.e. from 15.06.2021 to 14.07.2021 for outward loading of Sand traffic subject to restoration of passenger train service.

All other terms and condition issued earlier will remain unchanged.
