Railways desire that the charge notified for distances 1001 km and above (Rs 0.51 per
berth per km subject to minimum realization of haulage charges applicable on
distance of 1000 km. subject to minimum of Rs 610/-) shall be read as under:-

"Rs 0.50 per berth per Km subject to minimum realization of haulage charge
applicable on distance of 1000 Km. subject to minimum of Rs 610/-"
