Haulage charge for Postal traffic carried in Postal Vans and Non-Postal Vans for the year 2019-20 has been revised through above referred Freight Marketing Circulars dated 12.09.2019, 02.03.2021 and 05.05.2021.

2. It has now been decided to revise the Haulage charges for Postal Traffic carried in Postal Vans and Non-Postal Vans for the year 2020- 21 as under:

Distance Slabs	Haulage charge for the Postal Traffic (2020-21)
0-500 Km	Rs 0.99 Per berth per Km.
501-1,000 Km	Rs 0.63 per berth per Km, subject to minimum realization of haulage charges applicable on distance of 500 Km (subject to minimum of Rs 495/-)
1 001 Vm and	Rs 0.52 per berth per Km, subject to minimum realization of haulage charges applicable on distance of 1000 Km

subject to minimum of Rs630/-)

- 3. Point to point charges shall be rounded off to the next multiple of five.
- 4. Other terms and conditions mentioned in the letter dated 19.2.2007 and revised from time to time for charging of postal traffic, billing and payment will remain unchanged.
- 5. This issues with the concurrence of the Finance Commercial Directorate of the Ministry of Railways.
