Railway Board's vide letter under reference No.1 have granted approval to M/s
Adani Logistics Ltd. for procurement and operation of 08 (Eight) BOXNHL rakes in this
Railway under GPWIS.

M/s Adani Logistics Ltd. (ADIL) has inducted the 3rd rake (58 BOXNHL + 3 Spare and
01 brake van) to run between the approved circuits in S.E.C. Railway. The list of wagon is
enclosed as Annexure-I.

1. The subject rake will not be merged in IR's pool of wagons and distinctly indicated through a colour scheme. The rake so indicated shall run on aforementioned circuits only.
2. M/s Adani Logistics Ltd. (ADIL) to ensure access to and acceptance of train consisting of party's GPWs into each of the Private Terminals from where such train is originating and terminating prior to the dispatch of such train as Para 7.1.16 under Article-7 of the agreement.
3. Maintenance Depot: The maintenance of the wagons will be done by Railways at Bhilai on payment as per agreement entered into by the Party with the Railway.
4. Annual Maintenance Charges: M/s Adani Logistics Ltd. (ADIL) have acknowledged and agreed that the wagon maintenance charges shall be @2% of the 'current capital cost' of procurement of wagons. The 'current capital cost' shall be updated time to time as per extant policies of Railway Board. The current policy for arriving at current capital cost is as defined in Railway Board's letter No. 2010/AC-III/34/Pt.II/MIL-RAIL dated 17.06.2015 and No.2015/M(W)/814/18 dated:07.12.2012. The GST and other taxes applicable on maintenance charges shall be payable extra as per the applicable rate. The party shall directly deposit these taxes under Revers Charge Mechanism to Government directly under intimation to Railway Administration.

M/s Adani Logistics Ltd. (ADIL) shall have to pay the said amount in advance on quarterly basis to Railway by 7th of first month of the quarter. If payment is not received by the Railway administration within the due date then the party shall be liable to pay interest @ 12% per annum from the first day of the quarter till the actual day of realization.

5. Freight Concession in GPWIS:
 - i) Under GPWIS, M/s Adani Logistics Limited (ADIL) are eligible to get a freight rebate of 10% on the base freight rate prevailing at the time of booking.
 - ii) This freight rebate will be granted whenever the rake moves in loaded condition in the approved circuits.

- iii) When the end user pays the freight either as Consignor or Consignee the rebate shall be granted on the RR itself.
 - iv) When the freight is paid by either Consignor or Consignee who is not party to the Agreement under GPWIS with the Indian Railways, then the rebate (including when Indian Railways uses these wagons as per para 12 of Chapter III). For movement of goods shall accrue to the account of the party to the agreement. The payment of such amount shall be made to the party directly based upon a quarterly reconciliation by H. Qrs.
6. The term of the Agreement shall be for a period of 30 years (Codal life of the wagons inducted) starting from the date of this notification.
 7. The party shall be responsible to pay all charges and surcharges, fee, cess, duties, taxes etc. as payable on the basis of notification issued by the central and State Governments from time to time
 8. When the rake is loaded in the empty direction by Railway as per para 5.13.1 under Article-5 of GPWIS Agreement, an amount equivalent to 10% of the base freight will be credited to "Deposit miscellaneous" account specially created under a separate head for GPWIS repayment.
 9. In case where GPWIS rake is detained in private terminals (Port, CIL Sidings etc.) beyond the permissible free time, causing detention to other rakes in line to enter the terminal, detention charges as notified by Rates Branch from time to time, shall be levied even though rake is private and terminal being used is a non-railway terminal.
 10. The subject of BOXNHL rake will be governed by GPWIS agreement executed between this railway and M/s Adani Logistics Limited on 20.07.2021 and GPWIS Policy issued by Railway Board's FM Master Circular/GPWIS/2018/0 dated 26.04.2018 and corrigendum/addendum thereto issued by Railway Board from time to time.
 11. CGS/In Charge of concerned loading/unloading point shall maintain separate record pertains to each movement of GPWIS rakes of M/s Adani Logistics Limited (ADIL).
