Please find enclosed a copy of letter No. WCR/T-33/FOIS/Part-XX dtd.17.12.19 addressed to Executive Director (Rates), Railway Board on the above subject. It is represented in the letter that some block sections of WCR jurisdiction are wrongly reflected in jurisdiction of adjoining Railway in RBS. Also some interchange station are not correctly defined in RBS further, some interchange station are available in RBS which actually not physically as interchange station.

The issue has been examined in Board's office in consultation with efficiency & Research Dte. And following correct jurisdiction of various stations are as under:

- Katni Murwara (KMZ)-New Katni Jn. (NKJ) section is under jurisdiction of JBP div. of WCR.
- Katni Jn. (KTE)- New Katni Jn. (NKJ) section is under jurisdiction of JBP div. of WCR.

It is requested to make necessary corrections in RBS and other IT systems like FOIS, ICMS, CMS, COA etc. under intimation to Boards office and advised Zonal Railways accordingly.
