Sub: -Revision in passenger fare w.e.f. 01.01.2020.

In further clarification of Para 2 of CC 65 of 2019 dtd.31.12.2019, fare table for train services have been provided other than Humsafer, Antyodaya and Anubhuti Coach. The formula for charging fare for Humsafer, Antyodaya and Anubhuti Coach shall be as under:

S.no.	Train Type	Formula
1.	Humsafer	1.15 time of Mail/Express fare
2.	Antyodaya	1.15 time of Mail/Express fare
3.	Anubhuti Coach	1.2 time of executive class of Shatabdi train. If attached in Gatimaan train/Tejas train then fare of EC class applicable for Gatimaan train/Tejas shall be applicable.

2. As regards advance tickets issued to halt contractors, new fare structure issued vide Commercial Circular 65 of 2019. Shall be applicable w.e.f. 01.01.2020 and shall be sold on revised fare after having necessary corrections on tickets. Such alterations shall be made preferably by stamp or ink. Difference of fare shall be collected from the Halt contractor accordingly.

3. All other terms and conditions shall remain same as notified in CC 65 OF 2019 dated 31.12.2019.
