Sub: Movement of Rail Milk Tankers (RMTs) on Indian Railway

A meeting through Video Conference was held on 10.09.2020 with National Dairy Development Board and Members of Milk Co - operatives /Federations, regarding issue and problems being faced during transportation of milk products through Rail Milk Tankers over Indian Railway.

2. Some member have, inter- alia, requested for development / up- gradation of infrastructure and maintenance facilities at existing RMT handling points, provision of POH facilities at location close to loading points, attachment of RMTs in Mail/Express trains on regular basis, etc.
3. Transportation of milk products over Indian Railway has been indicated as a priority area by Hon'ble Prime Minister Zonal Railways are, therefore , requested to co-ordinate with NDDB/Milk Co- operatives/Federations and conduct a through review of issues concerning RMTs loading /unloading , maintenance etc, and do the needful to facilitate movement of milk/milk products through Railways.
4. For sake of clarity, it is stated that originating Railway shall be the Nodal Railway for all issue regarding operation of RMTs and for co- ordination with parties and en- route Railways.
5. Action taken may kindly be intimated to this office please.

All concerned staff please note and act accordingly.
