in Nagpur division over SECR.**

Reference is invited to this office Rates Circulars No. 193(G)/2020 dated: 19.11.2020, wherein Chiraidongri station (**Alpha Code: CID, Numerical Code:14223529**) of Nagpur division over SECR was notified as Goods shed for outward loading of Dolomite traffic. The Goods shed was opened as full rake handling point with placement in two parts on line No.2 (Main line). Further, it was notified for all commodities vide this office Rates Circular No.208(G)/2020 dated:09.12.2020.

Now, the work of full length Line (Line No.3) of Chiraigongri station (CID) has been completed and approved by competent authority (i.e. PCOM & PCCM) for opening of Chiraidongri station (CID) Line No. 3 as a Goods Shed full rake handling point with single placement instead of Line No.2.

Necessary RBS database may be updated accordingly. All terms and conditions notified earlier will remains unchanged.
