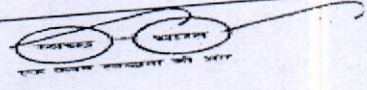

उपर्युक्त विषयक रेलवे बोर्ड के पत्र संख्या TC-II/2364/10/Haulage Charges दिनांक 19/02/2018 आपके सूचनार्थ एवं आवश्यक कार्यवाही बाबत पूर्ण विवरण नीचे दिया जा रहा है।

Haulage charges for Postal traffic carried in postal vans and non-postal vans for the year 2016-17 were revised through Freight Marketing Circular No.01 of 2016 dated 11.03.2016 and the same were retained for 2017- 2018 also vide Freight Marketing Circular no. 04 of 2017 dated 31.03.2017.


2. It has been decided to revise the haulage charges for postal traffic carried in postal vans and non-postal vans for the years 2018-19 as under:-

<u>Distance Slabs</u>	<u>2018-19</u>
0 - 500 Km	Rs. 0.96 per berth per Km.
501-1000 Km	Rs.0.62 per berth per Km subject to minimum realization of haulage charges applicable on distance of 500 Km. subject to minimum of Rs.480/-
1001 Km and above	Rs. 0.51 per berth per Km subject to minimum realization of haulage charges applicable on distance of 1000 Km. subject to minimum of Rs. 620/-

3. Point to point charges be rounded off to the next multiple of five.
4. Other terms and conditions mentioned in the letter dated 19.02.2007 and revised from time to time for charging of postal traffic , billing and payment will remain unchanged.
5. This issues with the concurrence of the Finance Directorate of the Ministry of Railway.
