Sub:- Fixation of siding charges for loading of fly ash at IBTB siding private siding of IB Thermal Power station owned by M/s OPGCL (IBTB) served by BPH station.

As per time & motion study and with the concurrence of Finance, the rate of siding charge for loading of fly ash from the private siding of IB Thermal Power station owned by M/s OPGCL (IBTB) served by BPH station has been fixed @ Rs. 1,19,497/- (Rupees one Lakh Nineteen Thousand Four Hundred and Ninety Seven only) per round trip from serving station BPH to Chharala (Exchange yard) and back, with Single Diesel Train Engine and back with double Diesel Train Engine, subject to adherence of the conditions laid down in Para 1807 of Indian Railway Code for traffic (Commercial). The above siding charge will effect from 28.09.2021.
