1. Guidelines for Transportation Products have been laid down in terms of above referred Rates Master Circular and Corrigenda thereto. 2. Matter has been reviewed and the Competent Authority has decided to delete **Para 7.1.vii** of Corrigendum no.24 to Rates Master Circular on Block Rakes/Mini Rake/Two Point Combination etc./2020.
3. All other terms and conditions laid down in above referred Rates Master Circular and Corrigenda thereto shall remain the same.
4. This shall come into force with immediate effect and shall remain in force till further advice.


