In connection with the above subject Rly.Bd vide letter under reference issued extracts of which is reiterated below for your information and necessary instruction.

Reference COO, Jagriti Sewa Sansthan letter dated 21-07-2016. **Ministry of Railways have, as a special case, decided to grant 25% concession in the basic fares in second and sleeper classes only for the special train on FTR booked by Jagriti Sewa Sansthan ex. Mumbai on 24-12-2016 and return to Mumbai 08-01-17.via Dharwad, Whitefield, Madurai Jn.Perambur , Gopalapatnam, Brahmapur, Raigir, Deoria, Sadar, Gorakhpur,Jn, Delhi-Safdarjang, Tilonia, Ajmer Jn, Kalol,Gandhi Nagar. Point to point charges should be calculated for every break point and also all other charges for the booking of special trains on Full Tariff Rates should be taken in full. Earnings/emoluments of the traveling persons should not be more then Rs.5000/-per month and traveling expenses are not borne by the Central or State Government, or by any local authority or statutory body or a Corporation or a Government undertaking or a University. Necessary instructions may be issued to the staff convened immediately. This issue with the concurrence of the Finance Directorate of the Ministry of Railways.**
