
**(Commercial Circular No. 07 of 2017)** is reproduced below for information and necessary action.

Concession to Sportsmen on the certificate issued by Indian Amateur Boxing Federation for participating in the tournaments was withdrawn. Further vide Commercial Circular No.43 of 2016 dated 19-08-16, it was decided that Secretary, Sports Authority of India or Executive Director (Teams), Sports Authority of India will issue concessional certificate to the Boxing Sports persons. Now, Ministry of Railways desire that since Ministry of Youth Affairs and Sports have recognized the Boxing Federation of India (BFI), 319, Udyog ,Vihar , phase-IV, Guru Gram ,Haryana, therefore, concession in Passenger fare as per Rule should be given on the certificate issued by Boxing Federation of India for Boxing sports. Authority given to Secretary , Sports Authority of India or Executive Director (Teams) from Sports Authority of India vide Commercial Circular No,43 of 2016 dtd.19-08-2016. Should be treated as withdrawn in the field of Boxing.

There is no other change in the rule and terms and conditions.

Necessary instructions may be issued to all conceded immediately
