It has been decided to revise the rate of Mela Surcharge w.e.f.15.04.2017 as under:-

Second (Ord/M/E)	5.00	5.00
Sleeper (Ord/M/E)	5.00	10.00
AC Chair Car & AC 3- tier	10.00	20.00
First (Ord/M/E)& AC 2 -tier	15.00	30.00
AC First	20.00	40.00

All other terms and conditions regarding levy of Mela Surcharge will remain the same.
