1.0 In terms of reference at (i) & (ii) above, Board's approval was communicated for restarting of 25 Tonne axle load operation with such rolling stock as are fit/ certified for 25 Tonne axle load on various notified routes.

2.0 The routes are notified in terms of Annexure-IV of reference (iii) above.

3.0 Matter has been examined, in the light of East Coast Railway's proposal. The Competent Authority has approved to add following routes in the list attached as Annexure-IV of Rates Master Circular under reference (iii) above, as 25 Tonne axle load notified routes:

1	Nergundi-Salegaon-Machapur-Rajathagarh-Budhapank-Angul-Kerejanga
2	Budhapank- Talcher
3	Talcher – Talcher Road
4	Gopalapatnam-Duvvada (including Bye Pass Line to Duvvada)

4.0 Accordingly Annexure-IV of Rates Master Circular under reference (iii) above shall be modified.

5.0 These instructions shall come into effect from 22.12.2021 and shall remain valid till further advice.
