Sub: Review of discount on base freight rate for 'Indented Parcel trains' with loading of 24/23 Parcel Vans plus Brake-van.



Vide the above referred Freight Marketing Circulars, eight percent (8%) discount was offered on the base freight rate of P-Scale applicable on Indented Parcel trains, if 24 (ICF-type Parcel Vans)/ 23 (LHB Parcel Vans) are indented for and loaded in a single Parcel train.

The matter has been reviewed and it has been decided to withdraw the above mentioned discounted scheme with immediate effect.
