
**Sub: Liberalised Automatic Freight Rebate Scheme for traffic loaded in
 Traditional Empty Flow Directions (TEFD)**

Ref : Rates Circular No.13 of 2021 and Corrigendum thereto.


- 1.0 In terms of Rates Circular under reference and corrigendum thereto, guidelines were issued for Liberalised Automatic Freight Rebate Scheme for traffic loaded in Traditional Empty Flow Directions (TEFD). This Scheme is operative upto 31.03.2022.
- 2.0 The matter has been reviewed. Competent Authority has decided to extend the currency of the subject policy beyond 31.03.2022 for a further period of one year i.e upto 31.03.2023.
- 3.0 It has also been decided to discontinue the TEFD benefit, which was available to inter-zonal traffic booked to 'Divisions of the destination zone other than notified Divisions'. Accordingly, the following table appearing in Para 1.7 (iii) of the Rates Circular No.13 of 2021 may be deleted.

Traffic	Existing Charging	Proposed Charging
Inter-zonal traffic: Divisions of the destination zone other than notified Divisions	Class 100(TL) and Class 110 (WL)	15% discount on NTR subject to floor limit of NTR of Class 100 (TL) and Class 110 (WL)

- 4.0 All other terms and conditions contained in Rates Circular No.13 of 2021 and corrigendum thereto, will continue to apply unchanged.
- 5.0 These instructions shall be operative w.e.f. 01/04/2022 to 31.03.2023.

6.0 This issues in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate in the Ministry of Railways.


