On the basis of Computer Based Test (CBT) and Computer Based Aptitude Test (CBAT) for the post of Station Master, Category No. 02 which were held on 02.01.2022 (1st shift) & 03.03.2022 respectively against General Departmental Competitive Examination (GDCE), the following candidates (1:1 numbers of notified vacancies) are provisionally found successful for Document and Candidature Verification against the notified vacancies. The result has been drawn only from amongst the candidates qualified in the CBAT with 70% weightage of the marks obtained in the CBT and 30% weightage of marks obtained in CBAT.
